Dear Member,

For a suggested \$10 donation per loan payment skipped, you can take advantage of this special offer! Enjoy some extra jingle in your pocket to knock out holiday shopping or pay down other debts - **all while helping your community.**

Qualifying loans may be skipped for one month - either November or December. This means that you may skip: (1) monthly, (2) bi-weekly or semi-monthly, or (4) weekly payments. Applications must be received **at least 3 business days before the loan due date** and must be returned no later than December 1, 2020. To qualify, loans need to be:

- 1. CLOSED-END (Most vehicle, student, and personal loans qualify).**
- 2. Have at least one payment already made.**
- 3. Not be past due at the time of your Skip-A-Payment request.**

You may have one or more loans eligible for this program. To apply, you must complete and sign the form below, and return to one of our offices by December 1, 2020. Payroll or ACHO payments will be deposited into your regular share account. Application must be received at least 3 days before loan due date. Payments will not be reversed. The Skip-A-Payment program only applies to payments due in November or December.

Regular monthly payments will resume in the month following the month you skip your payment. If you have GAP Protection, any amount of the loan that is skipped or delinquent may not be covered under GAP Protection. Mid-Kansas Credit Union reserves the right to reject any Skip-A-Payment request. Federally insured by NCUA.
